Reg : Appeal for Corpus Donation

----

Shivram Trust was formed by a regular Trust Deed dated 07.03.1997. Among other charitable objectives of the Trust, the main objective is to support, cherish and uphold our Vedic Heritage. Our thrust area is Veda Samrakshanam which in turn enriches our heritage and culture.

Over the years we had developed the pieces of lands purchased in Sriperumbudur, the Janmasthanam of Sri Ramanujar, and raised a nice and serene Veda Patashala. In 1998 we started the Krishna Yajur Patashala followed by Rig Veda in 2002, Sama Veda in 2004 and Shukla Yajur Veda in 2008. Each Veda is taught in separate location inside Patashala designed and constructed to reflect the traditions of Gurukula.

At present our Patashala is managed with two vedic sections namely Krishna Yajur and Sama Veda and having about 20 students. We have engaged Ganapatis permanently for teaching the vidhyarthi. Each vidhyarthi is supported by providing free boarding, lodging, clothing and other attendant amenities including medical aid for close to a decade. Till now, 30 vidhyarthi have completed their curriculum successfully in our Patashala in all the four vedas viz., Rig, Sukla Yajur, Krishna Yajur and Sama veda. The passed out students include Ganapatis as well as who completed three level of Vedic learning. Due to graduation of all existing students, we intent to recommence Rig veda and Sukla Yajur veda at an appropriate time in the near future.

Our patashala is recognised by Veda Rakshana Nidhi Trust under the supervision of Sri Kanchi Shankara mutt. We are also recognised by Shri Venkateswara Institute for higher Vedic studies under Thirumala Tirupathi Devasthanam. Kanchi mutt conducts annual examination from their end for running the patashala.

Our Patashala is also recognised by Maharshi Sandipani Rashtriya Veda Vidya Prathishtan, Ujjain under the purview and budgetary allocations of HRD ministry of the Centre, for aiding ancient studies to uphold our Vedic heritage and culture. They also conduct annual examinations and issue certificate on merits.

Besides regular Veda classes, students are taught general subjects like maths, science, social studies, English and Sanskrit languages by engaging separate teachers. The total cost of establishment which includes both both vedic and non-vedic teachers welfare and salary, administrative supervisors and other miscellaneous support persons salaries, food and medical expenses, maintenance charges & other related expenses in running and managing the Patashala worksout to Rs. 3 Lakhs per month. The average shortfall per month to make both ends meet is Rs. 1,25,000/-

With the dwindling interest rates, our current Corpus does not yield the desired interest income and the gap needs to be met with donation from individuals and corporates for raising the corpus fund to step up interest income.

Besides our proposed further projects like teaching Dharmashastras and higher studies beyond Ganantam, the third level of Vedic learning requires funds outlay. We have land available for taking up further projects, whereas we need funds for putting up super structures. This would cost approx. Rs. 6,00,000/- for construction of 600 Sqft.
